

1. The Simplified Installation Engine (“**Simplified Installation Engine**”) is the proprietary software of AppLogic Networks OpCo II LLC and/or its subsidiaries and affiliates (“**AppLogic Networks**”). The Simplified Installation Engine is licensed and not sold under this License.
2. AppLogic Networks retains all rights, title and interest in and to the Simplified Installation Engine and all copies thereof, including copyrights, patents, trade secret rights, trademarks and other intellectual property rights. All rights not specifically granted in this License are reserved by AppLogic Networks. The structure, organization and code of the Simplified Installation Engine are valuable trade secrets and confidential information of AppLogic Networks. You must use diligent efforts to protect AppLogic Networks intellectual property rights in the Simplified Installation Engine and will report promptly to AppLogic Networks any potential infringement of such rights. AppLogic Networks reserves the sole and exclusive right at AppLogic Networks discretion to assert claims for infringement or other violation of any AppLogic Networks intellectual property rights.
3. The Simplified Installation Engine may only be downloaded, installed and used in accordance with this License for the Purpose defined in this License.
